- DATE:** June 24, 2022

- SET UP TIME:** 7:00AM – 9:00AM Spots will be clearly marked and we will be on site beginning at 7:00 AM to provide assistance. **All vehicles must be off grounds and driveway by 9 a.m.**

- DEADLINE:** **June 1, 2022** or when show is filled. If space is available we will accept applications up to show day with a \$10.00 late charge.
- JURY:** New vendors must submit a list of their products along with representing photos. Photos can be submitted as attachment to an email addressed to [fair@eupmediate.org](mailto:fair@eupmediate.org). If sent by regular mail and you wish to have them returned, please provide a Self-Addressed Stamped Envelope. **No Commercial Vendors except Food. No Catalog sales.**
- CONFIRMATION:** Will be sent within 30 days of payment receipt. Confirmation must be prominently displayed in your booth during the show.
- FOOD LICENSE:** Vendors selling food must enclose a copy of your food license **when submitting an application**. Please wear gloves and keep foods needing refrigeration on ice. Dog/cat treat vendors must submit a copy of their agriculture license when applying.
- NSF CHECKS:** A \$35 fee will be charged for checks with insufficient funds. This fee must be paid by Money Order within 10 days along with any other monies due in order to receive a new confirmation for a space in the show or original space.
- NO RAIN DATE:** Priority given in 2023 if hard rain occurs. NO REFUNDS. You may write it off on your income taxes if cancelled due to hard rain.
- ALL CITY PARK RULES APPLY:** Everyone must abide by City Park rules. A few are: no alcohol, pets, fires or flames of any kind. DO NOT tear up grass or dig holes. Please leave it as you found it. Vendors are reminded that **City Hall Restrooms are for city business use only** and to please use the portable toilets we are providing.
