FEE SCHEDULE

This Center is committed to providing services to all in the Eastern Upper Peninsula apart from their ability to pay a fee. Individual circumstances that may allow a reduction or waiver of a fee should be discussed with the Executive Director.

A \$35 fee is charged for participants who do not show for a scheduled mediation; this fee is not waived. Participants unable to keep a scheduled appointment must reschedule mediation at least two workdays prior to the mediation to avoid this fee.

All Fees Must Be Paid Prior To Mediation.

General Mediation/Facilitation/Conciliation Services:

- **\$20** fee per party billed upon scheduling of **court-ordered Small Claims or Landlord/Tenant cases**
- **\$50** billed to the initiating party for **Self-referred** (not court-ordered) **Landlord/Tenant, Small Claims & all other District Court Matters.**
- **\$100** fee per party billed upon scheduling of **court-ordered General Civil cases.**
- **\$100** fee per party billed upon scheduling of **court-ordered Circuit Court cases.**
- **\$50** fee billed upon scheduling from the party requesting services in lieu of court.

Specialized Services

Eldercare, Adult Guardianship, Probate, Truancy, Family, Friends, Relationships & Other:

- **\$100** fee billed upon scheduling from party requesting services.

Divorce Mediations/Parenting Time

- **\$100** fee billed upon scheduling from each party involved.

Child Protection

- **\$250** fee billed upon scheduling to the referring agency or court-ordered case.

Conflict Resolution Mediation, Facilitation or Training for Businesses and Organizations

- **\$150/hour** billed upon scheduling from the party requesting services or for a class or workshop/10 participants - or negotiated amount.

Fresh Start Participants

- **\$150** fee and must be paid prior to scheduling.

Workplace Mediations

- **\$150** for up to two hours of mediation or facilitation.

Contract/Agreement covered cases:

- **No charge** to eligible participants where **the primary goal is for the Non-Custodial Parent to increase Parenting Time with his or her child(ren)** - State Court Administrative Office pays Center through Access & Visitation grant
- **No charge** to participants of **Special Education mediations, conciliations, facilitations, workshops, and presentations** –Michigan Special Education Mediation Program pays Center
- **No charge** to participants of **Civil Rights mediations** –Michigan Department of Civil Rights pays Center
- **No charge** to eligible participants of **Mental Health mediations that fall under the grant-** BHMS grant pays. All others are paid by HBH or Pathways.
